Re: Wild Ones Mid-Atlantic chapters support for funding the Mid-Atlantic Regional Seed Bank

Dear Martha,

Wild Ones Natural Landscapers, Ltd. is a Wisconsin-based national nonprofit environmental education and advocacy corporation. Across the country, over 11,500 Wild Ones members promote native landscapes through education, advocacy and collaborative action. Our 25 chapters in the Mid-Atlantic region require access to genetically appropriate native seed and a strong supply chain of native plant material. We fully support the Mid-Atlantic Regional Seed Bank (MARSB) in its effort to secure Department of Interior funds for critical work building Native Plant Material (NPM) supply chains across the region. This work advances the Department of the Interior goals, both embodied in its own National Seed Strategy Initiative and in the Biden-Harris administration's America the Beautiful initiative.

MARSB is an incorporated 501(c)3 nonprofit. Its goal is to run a six-point comprehensive program that develops all sectors of the supply chain and includes the fundamental work to identify, collect and bank local ecotype native plant seed (often from remnant populations) for essential workhorse species across seven states. State legislation mandating the use of native plant material highlights the need to increase availability and supply of local ecotype and appropriate native plant material to meet ever-increasing demand.

MARSB's director, Edward Toth, has been a leader in the NPM movement, most recently serving on the National Academy of Science's committee that produced the seminal report, An Assessment of Native Seed Needs and the Capacity for Their Supply. Through his forty years of work in the field, including founding and directing both New York City's Greenbelt Native Plant Center, and MARSB, he is experienced in all aspects of the supply chain—collecting, cleaning and banking wild seed, growing natives, increasing native seed supplies, and advising projects on the well planned and executed use of native plants in restoration, land management, and horticulture.

This program, if well-funded, will serve as a national model for development of regional NPM supply chains, the very foundation of critical work to mitigate climate-induced natural disasters, support pollinators, and restore biodiversity. Together with Wild Ones Mid-Atlantic Chapters, I ask USFWS Director Williams to critically review the MARSB program and consider how it might best provide meaningful support to its work.
